

Privacy Policy and Cookies

This document outlines the principles for processing personal data and the use of cookies by the Data Controller, **TV Republika Foundation, Inc.**, located at **1140 Avenue of the Americas, 9th Floor, New York, NY 10036**.

We are committed to safeguarding your personal data and ensuring that it is securely protected. Detailed information on the safeguards we implement can be found in the "**Data Protection Measures**" section of this Privacy Policy.

Your Rights Regarding Personal Data Processing

At any time, you have the following rights:

1. **Access Your Data** – You may request information about the data we hold and how it is being processed.
2. **Data Portability** – You have the right to receive your data in a structured, commonly used format that allows for its transfer to another data controller.
3. **Correction and Rectification** – You can update or correct data that is incomplete or inaccurate.
4. **Data Erasure ("Right to Be Forgotten")** – You may request the deletion of your data if there are no legal grounds for its continued processing.
5. **Restrict Data Processing** – You may request that the processing of your data be restricted under certain circumstances, such as when you contest the accuracy of the data or its processing is unlawful.
6. **Object to Data Processing** – You have the right to object to the processing of your data based on the legitimate interest of the Data Controller.
7. **File a Complaint with a Supervisory Authority** – In the United States, this would be the **New York Attorney General**; for data subjects in the European Union, this would be the appropriate data protection authority in your country of residence.

Limitations to Your Rights

Certain rights outlined above may be subject to limitations depending on the legal basis for processing your data or the requirements of applicable laws. For example:

- The **right to data erasure** does not apply where data retention is required by law (e.g., tax regulations or non-profit compliance rules).
- The **right to data portability** may not be applicable where the processing method does not meet the necessary criteria for this right.

Transparency in Data Processing

In the following sections of this document, we detail the purposes, scope, legal bases, and your rights related to each category of data we process.

Donations to the Foundation

Making a donation to the Foundation involves the processing of your email address.

Providing your email address is voluntary but necessary to execute the donation agreement. The legal basis for processing this data is the performance of the donation agreement (Article 6(1)(b) of the GDPR) and the legitimate interest of the Data Controller (Article 6(1)(f) of the GDPR), which includes sending a thank-you message for your contribution.

Your email address will also be processed to fulfill legal obligations, including tax compliance, as well as to handle any related inquiries or complaints regarding the donation.

Since donations on this website are processed using the **STRIPE** payment platform, your email address is also processed by STRIPE, which acts as an independent Data Controller. Detailed information on STRIPE's data processing practices can be found at <https://stripe.com/privacy>.

In connection with the processing of data for the donation agreement, you have the right to access your data, correct it, delete it, or restrict its processing.

We will retain your email address for the period necessary to meet legal obligations, including tax compliance (i.e., six calendar years). After this period, the data will be anonymized and used solely for statistical purposes.

If you wish for your email address to appear on the "Donor List" displayed on the website, you can provide your consent by selecting the appropriate checkbox. In this case, the legal basis for processing your data is your consent. Your data will remain on the list until replaced by new donation entries.

Visiting Our Website

Our website processes and collects information about visitors only to the extent necessary to provide high-quality services.

1. Server Logs

Visiting our website involves sending requests from your device to the server hosting the site. Each request is automatically recorded in server logs, which include:

- IP address,
- Date and time of the request,
- Browser details used to access the website.

The data stored in server logs does not allow the identification of individual users. These logs are used solely as support material for troubleshooting website issues. Access to this data is restricted to authorized server administrators.

2. **Anonymity of Visitors**

The data collected from website visitors does not enable the identification of their identity. Detailed information about data processing and tracking technologies, such as cookies, can be found in the section **Cookies and Other Tracking Technologies**.

Principles of Data Processing and Your Rights

1. **No Profiling**

Your personal data will not be subjected to profiling or automated processing.

2. **Your Rights**

Regarding the processing of personal data, you have the right to:

- Request access to the personal data we process,
- Correct or update your data,
- Request the deletion of your data ("right to be forgotten"),
- Restrict the processing of your data,
- Transfer your data to another entity,
- Object to the processing of your data.

3. **Response to Requests**

Upon receiving a request regarding your personal data, we will confirm its execution or inform you of the inability to fulfill the request, providing a justification, such as our legitimate interest, e.g., defending against potential claims.

4. **Complaints**

You have the right to file a complaint regarding data processing with the appropriate supervisory authority:

- In the U.S.: **New York Attorney General**.
- For EU residents: **the relevant data protection authority in your country of residence**.

In many cases, before taking action with the supervisory authority, it is required to first submit a request directly to the entity handling your data. Therefore, if you have concerns about how we process your data, we recommend contacting us first.

5. **Data Security**

We implement appropriate technical and organizational measures to safeguard your personal data. Detailed information about the security measures in place can be found in the **Data Protection Measures** section of this Privacy Policy.

Cookies and Other Tracking Technologies

Our website uses cookies and other tracking technologies to facilitate access to its resources. These technologies store useful information on your device and may be read by our server during your next visit. Cookies are used for the following purposes:

- Proper functioning of the website,
- Statistical purposes,
- Analytical purposes,

- Marketing purposes.

Your Options for Managing Cookies

You can configure your web browser to prevent cookies from being stored on your device. Detailed instructions on how to do this are available in your browser's settings or on the manufacturer's website. Disabling cookies will not block access to our website, but it may affect its usability.

You can also delete cookies after they have been stored by using your browser's functions, dedicated software, or tools available within your operating system.

Types of Cookies Used on Our Website:

Cookies Used for the Proper Functioning of the Website

Essential cookies enable the proper functioning of our website by activating basic features, such as navigating the site or accessing secure areas of the website.

Without these cookies, our website may not function correctly. Essential cookies are stored on your device for varying durations:

- Some cookies are stored only for the duration of the session (i.e., until you leave our website),
- Others are stored for a period of 2 hours,
- A cookie that records your consent for other (non-essential) cookies is stored permanently.

You can delete stored cookies at any time by using your web browser's settings.

Analytical/Statistical Cookies

Analytical and statistical cookies help us understand how users interact with our website by collecting and reporting information anonymously.

For statistical analysis and data collection regarding visits to our website, we use the following services:

- **Google (Google Analytics)** – Since Google is based in the United States, information stored in cookies may be transferred outside the European Economic Area. Details about data processing by Google can be found in Google's Privacy Policy: <https://www.google.com/policies/privacy>.
